Bidders for Lot Numbers:1, 3 and 5 GESD Project should have a minimum of 200.0Million NCIC – Buildings Category;

Bidders for Lot Number: 2 GESD Project should have a minimum of 500.0Million NCIC – Buildings Category

4. Bidding will be conducted in accordance with National Competitive bidding (NCB) under works category and Procedures contained in the public procurement Act and Regulations of the Republic of Malawi and is open to all bidders.
5. A complete set of bidding document in English language may be purchased by interested bidders at a Non-Refundable Fee of Mk 30,000.00 (Payable at Chikwawa District Council's Cash office) followed by the collection of the document from the address indicated below starting from 23rd April, 2024 during working hours.
6. Sealed bids must be delivered to the address below on or before 24th May, 2024, 02:00 pm hours. All bids must be accompanied by a BID SECURING DECLARATION. Late bids shall be rejected. Bids will be opened in the presence of the bidders' representatives who choose to attend on 24th May 2024, 02:00 pm hours (local time).
7. Pre-bid meeting and site visit will be conducted as follows;
 - a. Chikwawa District Council Chamber on 30th April, 2024 9:00 am hours where places like Maperera, Matsukambiya and Nsangwe will be visited.
 - b. Chikwawa District Council Chamber on 1st May, 2024 9:00 am hours where place like Gola will be visited.
