#### **TENDER FOR CONSTRUCTION OF NEW WATER SUPPLY SCHEME AT ZALEWA TRADING CENTRE**

1. **Background:** Southern Region Water Board (SRWB) is a statutory body that was established in 1995 by the Laws of Malawi (cap.72.01) with the mandate to construct, maintain and extend all waterworks, for the purpose of supplying potable water for domestic, public, commercial and all other purposes to which water and waterworks are supplied or are applicable in Southern Region.
2. Southern Region Water Board (SRWB) has received funding from Malawi Government for the Construction of New Water Supply Scheme at Zalewa Trading Center. The project will be implemented by SRWB under the responsibility of Malawi Government.
3. SRWB now invites sealed bids from eligible Civil Contractors who are registered with NCIC in the **UNLIMITED** Category for the works indicated above.
4. Bidding will be conducted in accordance with Open Tender procedures contained in the Public Procurement and Disposal of Public Assets Act No.27 of 2017 and Public Procurement Regulations, 2020 of the Government of the Republic of Malawi.

6. Bids, clearly marked "Tender for Construction of New Water Supply Scheme at Zalewa Trading Center" must be delivered to the address below by **Monday, 23rd December, 2024, before 14:00 hours local time**. Late bids will be rejected.
