



INVITATION FOR BIDS (IFB) DISPOSAL OF VEHICLES THROUGH SEALED BIDS

1. **Air Cargo Malawi Ltd** in line with its 2024/2025 disposal of assets plan intends to dispose of unserviceable motor vehicles.
2. The Chairperson, Internal Procurement and Disposal Committee for Air Cargo Malawi Ltd hereby invites sealed bids from eligible bidders for disposal of vehicles as follows;

3. A bidder may bid for either one or multiple lots. All bids must be accompanied with a valid National identity in full colour.
4. Bidding will be conducted through the disposal procedures contained in the Public Procurement and Disposal of Public Assets Act, 2017 and is open to all eligible bidders.
5. **DEPOSIT**
All bidders shall be required to pay a refundable deposit of **K500,000.00/ LOT** when submitting their bids. The deposit is **REFUNDABLE** only where a bidder is not successful and **FORFEITED** when a successful bidder declines to take up one's bid for whatever reasons.
6. Successful bidders shall be required to pay 100% of the contract price within 30days from date of award of contract. Allowable Modes of Payment are **STRICTLY CASH** or **BANK CERTIFIED CHEQUE**.
7. Successful bidders will be expected to pay duty for the vehicles that were bought duty free.
8. In accordance with Section 35 of the Public Procurement and Disposal of Public Assets Act, 2017, all members of staff of Air Cargo Malawi Ltd and the Board of Survey Members and their close relatives shall not be eligible to participate in this sale.

Electronic bidding will NOT be permitted. Late bids shall be rejected and returned unopened.
