2. The Alliance of Bioversity & CIAT now invites sealed Bids from eligible National Tenderers for the Proposed Refurbishment of CIAT offices located at Chitedze Research Station Lilongwe, Malawi.
3. Bidding will be conducted through the **Open bidding Method** whereby all building contractors registered with National Construction Industry Council of Malawi in the **Five (5) Billion Kwacha Category and above** are invited to bid.
4. Interested eligible bidders may obtain further information/ clarifications from the office of **The Alliance of Bioversity & CIAT P.O.BOX 158 Chitedze Research station located along Mchinji Road Lilongwe, Malawi.**
5. **Site Visit / Inspection of Works**
All interested contractors who have expressed their interest and have received bid documents shall be required to attend a Mandatory site visit at their own cost scheduled at **10:00Hrs on 8th April 2025**.
