



# INVITATION FOR BIDS (IFB)

**Total LandCare (TLC)** is a non-profit organization implementing development programs in Malawi, Zambia, Mozambique, and Tanzania. TLC's mission is to transform the livelihoods of rural households from subsistence to prosperity and self-reliance. Achieving this goal involves building the capacity of organized groups of farmers, cooperatives, and related local governance structures to integrate sustainable agricultural and natural resource practices with initiatives to strengthen livelihoods and value chains linked to micro-finance and markets. The ultimate aim is to increase farm productivity, diversification, profitability and resilience with lower input costs and sound management of the landscape for current and future generations.
