

CALL FOR PREQUALIFICATION OF SUPPLIERS OF GOODS AND SERVICES

INTRODUCTION

Water Services Association of Malawi (WASAMA) is a governing member for Malawi to the International Water Association (IWA) and Eastern and Southern Africa Water and Sanitation (ESAWAS) Regulators Association, which are global networks of water professionals. - Evidence of at least one previous contract or Local Purchase Order (LPO) executed within the last two years, if possible.
- · Names of directors to meet the beneficial ownership disclosure requirement.
