EXPRESSION OF INTEREST TO SUPPLY MAIZE TO ADMARC

ADMARC Limited is a state-owned enterprise whose mandate is to contribute to the socio-economic development of the country through marketing agricultural commodities, products and services, value addition to agricultural produce for both local and export markets, implementing government agricultural policies such as food security and price stabilisation and agricultural production, among others.

Out of the funding ADMARC got from the government, some funds have been set aside for maize purchases.

It is in this light that ADMARC is calling for Expressions of Interest from individual farmers, farmer cooperatives and grain traders to supply maize in bulk to ADMARC through the bulk purchase window that is to be supplied to all ADMARC depots and some selected markets across the country.

The depots and markets are as follows:

REQUIREMENTS

The requirements for the bulk purchases/selling are as follows:

1. Good quality maize with the following specifications
 - a. Colour White Production years 2023 & 2024
 - b. Moisture content (% max) 12.5 - 13.0
 - c. Rotten & Diseased grain (% max) 1
 - d. Shriveled grain (% max) 1
 - e. Weeviled grain/Pest damaged grain (% max) 1
 - f. Other coloured grain (% max) 2.0
 - g. Broken grain (% max) 3.0
 - h. Extraneous Matter and Trash/ Foreign matter (% max) 1
 - i. Germinated grain None
 - j. Contaminants None
 - k. Live insects None
 - l. Aflatoxin content, ppb, maximum 10.0
2. A minimum of 30 MT
3. Delivered to depots or selected markets
