The Department of Human Resource Management and Development (DHRMD) has budgeted resources in the Financial Year 2025/2026 towards the cost of implementing various programmes and it intends to apply part of the funds towards payments under contracts for **Provision of Health Insurance Services for Civil Servants**.

2. The Chairperson, Internal Procurement and Disposal of Assets Committee, Department of Human Resource Management and Development (DHRMD), on behalf of the Government of Malawi now invites sealed bids from eligible and qualified bidders for the Provision of Medical Insurance Services as follows:

3. Bidding will be conducted through National Competitive Bidding (NCB) procedures specified in accordance with the Public Procurement and Disposal of Assets Act (No.27 of 2017) and Regulations of the Government of the Republic of Malawi and is open to all eligible bidders.

5. A complete set of Bidding Documents in English Language may be purchased by interested bidders at the address below at paragraph 8 (b), upon payment of a non-refundable fee of MK5, 000.00 (Five Thousand Kwacha). The method of payment will be cash and a General Receipt will be issued.

6. The Bidding Documents will be issued to the bidders immediately upon presentation of an Original General Receipt as a proof of payment and bidding documents will be issued from the **Procurement and Disposal Unit, First Floor Room Number 36A**.

Sealed Bids clearly marked on the outer envelope "**Tender Description and Reference Number**" must be delivered to the address below at 8 (c) on or before **17th June, 2025, 14:00 hours local time**. Electronic bidding **will not be permitted**. Late bids will be rejected. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below at paragraph 8 (d) on **Tuesday 17th June, 2025 at 14:00 hours local time**. All bids must be accompanied by duly signed Bid Securing Declaration Form on the bidder's letter head.
