## INVITATION FOR BIDS (IFB)

### SUPPLY AND DELIVERY OF PESTICIDES FOR CONTROL OF FALL ARMYWORM AND AFRICAN ARMYWORM

1. The Government of the Republic of Malawi (GOM) through the Ministry of Agriculture (Department of Crops Development), has budgeted resources to be used in the Supply and Delivery of pesticides for control of fall armyworm and African armyworm.
2. The Ministry of Agriculture now invites sealed bids from eligible and qualified Bidders for the supply of the following items:

1	Chlorpyrifos 480g/l (Organophosphorus) or combined with another active ingredient	69,400	Area 10 Warehouse	4 weeks

3. Bidding will be conducted through the Open Tendering procedures contained in the Public Procurement Act 2025 and Public Procurement Regulations 2020 of the Government of the Republic of Malawi and is open to all eligible bidders.

Electronic bidding will not be permitted. Late bids will be rejected and returned to the owners unopened. All bids must be accompanied by a Bid Securing Declaration.
