Electronic bidding will not be permitted. Late bids will be rejected and shall be returned to the owners unopened. All bids must be accompanied by a Bid Securing Declaration.
- Bids will be opened in the presence of the bidders' representatives, who choose to attend in person at the address in 9 (d) below on **Wednesday 09th July, 2025, 10:00 hours** (local time).
