3. Bidding will be conducted in accordance with the Open Tendering Procedures contained in the Public Procurement and Disposal of Asset Act No 7 of (2025) and Public Procurement Regulations 2020, of the Government of the Republic of Malawi and is open to all qualified and eligible bidders.
4. Interested eligible bidders may obtain further information or inspect bidding documents at the address given below in paragraph 9 (a). Inspection of the bidding documents may be done from 8:00 to 12:00- 1300 to 1600 hrs. (Monday to Friday), except national public holidays.
5. A complete set of bidding documents in English may be purchased by interested bidders at the address below in paragraph 9 (b) and upon payment of a non-refundable fee of **MK10,000.00 (Ten Thousand Malawi Kwacha only)**.
6. Bids in sealed envelopes and clearly marked with the tender number must be delivered at the address given below in paragraph 9 (c) on or before **Tuesday 05th August, 2025, 10:00 hours (local time)**. Electronic bidding will not be permitted. Late bids will be rejected and shall be returned to the owners unopened. All bids must be accompanied by a Bid Securing Declaration.
7. Bids will be opened in the presence of the bidders' representatives, who choose to attend in person at the address in 9 (d) below on **Tuesday 05th August, 2025, 10:00 hours (local time)**.
