

INVITATION FOR BIDS FOR SUPPLY AND DELIVERY OF GOODS AND SERVICES (NATIONAL COMPETITIVE BIDDING)

1. The Greenbelt Authority (Authority) was established by the Greenbelt Authority Act of 2025 to champion large-scale commercial irrigation whose main purpose is to accelerate social-economic transformation through increased agricultural productivity, agro-processing and easy access to markets.
2. The Authority has budgeted public funds to be used for the procurement of Goods and Services. The Authority now invites sealed bids from interested eligible bidders for the procurement of the following:
