The Government of Malawi through Ministry of Transport and Public Works has budgeted resources in this financial year 2025/26 towards the cost of implementing various programs in the Transport Sector and it intends to apply part of the funds towards payments under the Contracts for Supply and Delivery of 4x4 Airport Bird Scaring Vehicle Double Cabin Pick up.
2. The Ministry of Transport and Public Works now invites sealed bids from interested and eligible bidders to submit their sealed bids for Supply and Delivery of 4x4 Airport Bird Scaring Vehicle Double Cabin Pick up.

Bidding will be conducted in accordance with International Competitive Bidding (ICB) procedures contained in the Malawi Public Procurement and Disposal Act of (2025) and Public Procurement Regulations of the Government of the Republic of Malawi of 2020, and is open to all bidders from eligible source countries.

Interested eligible bidders may obtain further information and inspect the bidding document at address 8(a) or from Procurement office room number 41 at the Ministry of Transport and Public Works from 08:00 hours to 12:00 noon and 13:00 to 16:00 hours local time (Monday to Friday), except during national public holidays and weekends.

A complete set of bidding documents in English language can be purchased by interested bidders on the submission of a written application to the address 8(b) below and upon payment of non-refundable fee of **MK20,000.00 (Twenty Thousand Kwacha only)** or its equivalent in USD. The method of payment will be cash or bank certified cheque.
