DRILLING OF 15 BOREHOLES AT VARIOUS HEALTH FACILITIES IN MALAWI

1. **The Ministry of Health** has budgeted funds from Government of Malawi funded by the German Government through KfW under the Health Services Joint Fund (HSJF) and intends to apply part of the proceeds for payments under the Contracts for Drilling of Boreholes at various Health Facilities in Malawi.
2. The Chairperson of Internal Procurement and Disposal of Assets Committee now invite sealed bids from eligible and qualified bidders who are currently registered with the National Water Resources Authority and in the MK1Billion category or above with the National Construction Industry Council of Malawi (NCIC) for drilling boreholes and construction of Water Tank Stands and associated water reticulation works at the following health facilities:

Bidders are requested to quote for all items in a contract as failure to do so will lead to automatic disqualification for non compliance. No Bidder shall be awarded more than one Lot. A bidder can however, bid for all contracts to increase chances of success.

3. Bidding will be conducted in accordance with the open tendering procedures contained in the Malawi's Public Procurement Act of 2003 and Procurement Regulations of 2004 and is open to all eligible bidders as defined in the Bidding Document. A bidder shall be required to obtain a certificate of registration from the National Water Resources Authority and the National Construction Industry Council demonstrating registered contractor status, as a condition for contract award.

5. Bidding documents will have to be collected in person. Only Bidders who have registered and acquired bidding documents as specified in Clause 4 above shall be eligible to submit bids.
6. Bids shall be deposited in the tender box on the Ground Floor, at Ministry of Health, P.O Box 30377, Capital City, Lilongwe 3 to be received not later than **10.00 hours local time on 8th October, 2025**. Late bids will be rejected and returned unopened.
7. Bids will be opened in the presence of bidders and/or their representatives and members of the general public who choose to attend the opening of bids at 10.00 a.m. local time on **8th October, 2025 at Ministry of Health, Capital city, in the main Conference Room, located on the 2nd Floor.**
8. All bids shall be accompanied by a Bid Security of **MK5, 000,000.00 (Five Million Malawi Kwacha)** or in case of a Bid from a (100%) Malawian owned firm, by a Bid Security Declaration Form.
9. It is the responsibility of each bidder to ensure that its bid is submitted in accordance with **"Instructions to bidders"** and in compliance with the bidding documents, as non-compliance to the instructions will lead to disqualification and rejection of its bid.
10. Bids shall remain valid for a period of **120 days** after date of bid opening.
11. The Malawi Government (Ministry of Health) does not bind itself to accept or reject any or all bids and reserves the right to exercise choice of the lowest evaluated and substantially responsive bid, provided further that the bidder is determined to be qualified to perform the contract satisfactorily.
