Bids must be deposited in the tender box on second floor reception, **MRA Msonkho House, Blantyre** at or before **15:00 hrs**, local time on **13th October, 2025**. Late bids shall be rejected. Bids shall be opened in the presence of the bidders' representatives, who choose to attend the opening proceedings at **15:00 hrs on 13th October 2025**.
