2. Malawi Electoral Commission (MEC) is inviting sealed bids from eligible bidders for the **Provision of Insurance brokerage services**.
3. Bidding will be conducted in accordance with the open National Competitive Bidding (NCB) procedures contained in the Government of Malawi's Public Procurement Legal Framework and is open to all bidders.
