The method of payment will be cash or bank certified cheques only.
6. Bids must be delivered in sealed envelopes clearly marked contract number, contract name and constituency name at or before 14:00pm on Monday, 3rd August, 2026 at the address indicated below.
7. All bids must be accompanied by a Bid Securing Declaration. Late bids shall be rejected. Bids will be opened in the presence of the bidders, or their representatives, who choose to attend at DEDZA Chamber at 14:00pm on Monday, 3rd August, 2026.
8. Dedza District Council shall hold a Pre-Bid Meeting on Monday, 20th July, 2026 at 09:00am at Dedza Council. The pre-bid meeting shall be preceded by a site visit.
